ORDINANCE NO. 2017-06

AN ORDINANCE TO PROVIDE FOR THE ISSUANCE OF CITATIONS FOR MUNICIPAL CIVIL INFRACTIONS AND TO PROVIDE THE PROCEDURES THEREFOR

THE TOWNSHIP OF SELMA ORDAINS:

Section 1. Supervisor's Authority to Issue Citations. The Township Supervisor or designee is authorized to issue citations for violations of any Township ordinance which is designated to be a municipal civil infraction if the Supervisor has reasonable cause to believe an infraction has occurred, based upon either personal observation or upon the report of a person who has allegedly witnessed said infraction.

Section 2. Other Authorized Local Officials. The Township Board may appoint, by resolution, other authorized local officials having the authority to issue citations for violations of any Township ordinance which is designated to be a municipal civil infraction. Such an authorized local official may issue citations if he or she has a reasonable cause to believe an infraction has occurred, based upon either personal observation or upon the report of a person who has allegedly witnessed said infraction.

Section 3. Form of Citations. Municipal civil infraction citations shall be numbered consecutively and shall be in a form approved by the State Court Administrator's office.

Section 4. Service of Citations. Municipal civil infraction citations shall be served upon the alleged violator as provided by law.

Section 5. Appearance. Municipal civil infraction citations shall require appearance at the district court within a reasonable time after the citation has been issued.

Section 6. Severability. In the event that any provision of this ordinance is held to be invalid, such holding shall not affect the validity or enforceability of any of the remaining provisions of this ordinance.

Section 7. Repeal. All resolutions or ordinances, and parts thereof, which are in conflict, in whole or in part, with any of the provisions of this ordinance are hereby repealed.

Section 8. <u>Publication; Effective Date.</u> A summary of the regulatory effect of this ordinance shall be published in a newspaper of general circulation in the Township, within 30 days after adoption. The ordinance shall become effective 30 days after such publication.
