2. VC3/IT Right: Perrin, we have been with VC3 (IT Right) since 2015. They are raising their rates. Rates have not been raised since 2015. Current rate=\$3,630. 2023: +\$834=\$4,464 (or \$372/month); 2024: +\$1,026=\$5,490 (or \$457.50/month); 2025: +\$1,230=\$6,720 (or \$560/month). Then will be annual 4% increases or CPI in following years. Boyd discussed his concerns of no one getting back with him regarding his printing issues. Perrin & Hettich have no complaints with VC3. Perrin will get someone to take care of it. Motion to continue with VC3 at their new rates – Perrin/Boyd – P,B,K,H,W – all yes

3. Early Voting: Perrin – Proposal 2022-02 gave voters 9 days in which to vote early. This is extremely costly. Selma Township's upcoming early voting will be combined with other Townships in the County and will be held at the Lake Street Building in Cadillac (where Michigan WORKS was). Voting on the day of election for Selma Township will still be held at Selma Township Hall.
