<u>Jackie Erway:</u> Cherry Grove Twp Board voted in February to withdraw from Joint Planning Commission (unanimous vote) because of the frustration over the past year, trying to get things done. Their board has been expressing their concerns with what they want, but the Joint Planning Commission doesn't seem to be listening. A lot of things with the Joint Planning Commission are geared toward large communities and not structured for our area. The Joint Planning Commission does have an ordinance regarding short-term rentals, and that ordinance states there are 3 ways to have a STR in Wexford County: 1. If it was established before January of 2017; 2. Special Use Permit; 3. If you reside on the property the rental is on. There is a lot of frustration, as citizens can't get a straight answer on who to go to in order to get enforcement.
